The brother of the great chemist Sir Humphrey Davy, whose works he'd edited, in nine volumes, John Davy's researches here include the torpedo, poisonous snakes of Ceylon, the temperature of the insane, and many other topics.

A pupil of Ashley Cooper, he particularly distinguished himself in vascular surgery and in operations involving the bones and joints," Garrison-Morton, p. 691. [31913] \$250
